

IT'S YOUR RIGHT TO READ

Get Involved!

Readers can voice censorship concerns, celebrate free expression, and show their communities the importance of intellectual freedom.

Here's what you can do to fight censorship, keep books available in libraries, and promote the freedom to read:



STAY INFORMED

Find out your library's policy for reviewing challenged materials. Stay updated about intellectual freedom by signing up for the free [Intellectual Freedom News](#) newsletter, or reading the [Journal for Intellectual Freedom and Privacy](#).



READ THE BOOKS

Exercise your reading rights. Check out a banned book. Encourage your book club to discuss rebellious reads. Many challenges to materials are the result of isolated passages taken out of context, so understanding the material is crucial. After reading the material, you will better understand the literary merits of the book as well as the concerns of the challengers, which will prepare you to counter any objections to the material you are trying to defend.




SHARE BOOKS

SPEAK OUT & SPREAD THE WORD


Use the hashtag **#BANNEDBOOKS** to declare your right to read.



KNOW YOUR RIGHTS

Knowing your rights when it comes to certain materials being banned is important because it will lend weight to your argument when speaking to people of authority. Nearly all libraries in the US function under the Library Bill of Rights as set by the American Library Association (ALA). [The Library Bill of Rights](#) supports the First Amendment of the US Bill of Rights and protects your right to read materials from all points of view. REPORT CENSORSHIP

The [ALA's Office of Intellectual Freedom \(OIF\)](#) reports that though they receive information about numerous bans/challenges, they estimate that the numbers are lower than reality because many challenges are not being reported. Censorship thrives in ignorance. The best way to prevent it is to make sure that free expression advocates know it's happening, even if an official challenge hasn't been made yet. If a book is challenged at your school or public library, please report it.
