





Campbell, a professor of anthropology at George Mason

University, who has written a great book on grilagem titled *Conjuring Property: Speculation and Environmental Futures in the Brazilian Amazon*. The work of geographer Susanna Hecht, historians John Hemming and Barbara Weinstein, and reporter Sue Branford was also very important. Last but not least, a great thanks to Danicley de Aguiar, from Greenpeace Brazil, who first made me aware of Maria Joel's story.

# A Note on Sources

This book is a work of nonfiction, and no dialogue or event is invented. The unfolding of events is also presented in the real chronological order.

Very few works exist on the history of Vila Rondon. Most studies are prepared as master's and doctoral dissertations. Therefore, the backbone of my research stems from two categories of sources: the testimony and accounts of some two hundred interviews, mostly performed by me in Rondon do Pará and other areas of Brazil, and about 100,000 pages of documents, most of them unpublished, drawn from Brazilian state and federal courts, notary public offices, press clippings, and private and public archives and libraries located in five Brazilian states, Italy, and the United States.

Oral sources—especially the living memories of pioneers who were willing to talk to me—were crucial for re-creating some passages, events, and places in the most detailed and faithful way possible, which I believed was important to tell this story. Whenever possible, I gave voice to eyewitnesses, but hearsay accounts from secondary sources, like the relatives of dead victims, were also important. Officials were equally central to writing this book, and I interviewed dozens of former ministers, current and former state and federal lawmakers, law enforcement agents, federal and state judges, and prosecutors. Most interviewees were willing to talk on the record, but others asked to remain completely anonymous.

Individual memory is fallible, especially when sources are recollecting events from several decades prior, and the debate over land

ownership and frontier expansion in the Amazon is polarized and controversial. For instance, many used the word *fazendeiros* or large landholders as a euphemism for a world of people who are half rural businessmen and half criminals. (Of course when I refer to a person in this book as a fazendeiro, that by no means indicates that he is an outlaw or someone who has ever committed a crime. Most Brazilian fazendeiros are law-abiding citizens and successful and ethical businessmen.) Therefore, I have undertaken extensive cross-checking and have tested the memories of my most important sources in order to write an account as close to the facts as possible. Maria Joel, Brito, and Francisco, for example, were interviewed multiple times. When possible, I also corroborated oral accounts with documentary evidence. As a result, this book contains a large number of endnotes.

Brazil and its constitutional and legal framework allowing journalists to access public information and documents deserve credit, and the evidentiary lattice of this work would have been much different otherwise. Through Brazil's freedom of information act (Lei de Acesso à Informação. or LAI), I filed dozens of requests for access to documents from the municipal, state, and federal governments, and, in most cases, I received the information I requested. LAI helped validate many stories I was told orally in Rondon do Pará. Some of the most sensitive material of this book, however, was already available to the public in the extraordinary Arquivo Nacional, especially hundreds of confidential dossiers produced by several information agencies during the military dictatorship (1964–1985).

Accessing court documents proved slightly more difficult and time-consuming. I had to hire lawyers to get access to some court cases archived in Rondon do Pará's house of justice, and the files of the "chainsaw case" were not found in the archives when I was granted access by the president of Pará's justice system. But in general terms, and despite some bureaucratic snags, I felt that the right to information prevailed in most cases, and civil servants and judges granted me unrestricted access to information crucial to writing the book.

According to written official records, Josélio de Barros Carneiro ad-

mitted to his participation in five murders: three in Espírito Santo and two in Rondon do Pará.¹ Several reliable accounts attribute many more crimes to him, though. This myriad of accusations made it difficult for me to verify what was true and what was perhaps an exaggeration or part of a defamation campaign, as Josélio often claimed. Therefore, to tell the most controversial parts of his personal story, I have relied almost entirely upon written records from official sources, such as the documents of some twenty civil and criminal cases. They validated, in most cases, what I had heard about Josélio from sources in both Pará and Espírito Santo.

Understanding the backgrounds of Josélio and Nunes was fundamental, and I have also relied on oral sources sympathetic to them. One of Josélio's brothers, José Francisco de Barros, was interviewed twice. His information proved fundamental to understanding Josélio's early days and the story of his family in the complex and volatile Espírito Santo of the 1950s and 1960s. However, none of Josélio's daughters or his son cooperated with the research for this book. I was particularly interested in interviewing Shirley Cristina, who was Rondon's mayor in addition to Josélio's most trusted daughter, because she had her own story to tell. But she never responded to my requests, although she has given many interviews to the media over the years. Only one of Josélio's six children ever replied to my emails, phone calls, or letters—but only to say that she'd never say a word to me, and that if I persisted in requesting an interview, she would sue me.

I also contacted Décio José Barroso Nunes through one of his brothers and, more important, through his lawyers, but I failed to get an interview with him. The two attorneys who represented him in the 2014 and 2019 jury trials for the murder of Dezinho, Roberto Lauria and Antônio Maria Freitas Leite Jr., respectively, also declined to be interviewed.

Still, this book is largely built on information from Josélio and Nunes. Both fazendeiros have been involved in civil and criminal litigation for several decades. Their version of the facts was in tens of thousands of court files, as well as in occasional interviews with the press, so I have

incorporated their words in the text and duly annotated the sources. Some of Nunes's defense attorneys in civil cases also granted me interviews.

Anything that appears in the text between quotation marks has been told to me during interviews or is sourced in police files, court documents (including transcripts and informant statements), diplomatic cables, and files from the Brazilian congress and senate, the Indian Protection Service (SPI), the National Indian Foundation (FUNAI), the Brazilian Institute of Environment and Renewable Natural Resources (IBAMA), the Land Institute of Pará state (ITERPA) and the National Institute for Colonization and Agrarian Reform (INCRA). I've also drawn upon a wide range of documents from institutions such as the International Committee of the Red Cross (ICRC); Centro Missionario—Diocesi di Piacenza Bobbio; the Pastoral Land Commission (CPT); and Armazém da Memória. They are all mentioned in the notes.

When I attribute some thoughts to the sources, it is because those sources expressed them to me or to an interviewer like a police officer, a judge, or an attorney, or I read about it in official documents. At times, the thoughts of some characters were conveyed to a third person I have later interviewed. This is the situation, for example, with Maria Joel (Dezinho) and with Francisco (Pedro).

### A NOTE ON SOURCES

1. In a signed statement addressed to the court in Espírito Santo, Josélio had admitted to the murder of the two alleged hitmen about to kill his father in Baixo Guandu's train station and the murder of Major Cavalcanti. The signed statement and the motion by his defense attorney, Mario Rocha, is in the files of court case 1.277/67, Vitória, Espírito Santo. According to the report of detective Adonias Marques dos Santos, December 1975, in classified file ACE 3582/83, Josélio also admitted to have hired out the murders of Reis and Vieira, in the so-called chainsaw murder.
